Pablo Marco has led aid programs during the largest humanitarian crisis of the 21st century as country director, regional desk, and member of the board of directors of Médecins Sans Frontières. He has worked in Yemen, Syria, Iraq, Palestine, Haiti, the Central African Republic, Ethiopia, the Democratic Republic of Congo, Liberia, and several other countries. During 15 years of professional experience, he has been involved in high-stakes negotiations with governments at the ministerial level, military leaders, non-state armed groups, civil society groups, UN missions, and private donors.

In addition, he has pursued a career in digital entrepreneurship. He founded one of Spain's earliest e-commerce ventures in 2006 and currently serves as the CEO of Fáktica Analytics, a consultancy specializing in digital marketing.

## SUBJECT DESCRIPTION

This course offers a comprehensive exploration of international development, emphasizing the critical role of multi-stakeholder partnerships in addressing global challenges. Students will analyze the evolution of international development theories and policies, examining their origins, progression, and current paradigms.

Participants will gain an understanding of the diverse actors in international development, including governments, multilateral organizations, civil society, and the private sector. The curriculum highlights the significance of partnerships and innovative financial instruments in mobilizing resources and achieving development goals.

Key topics include the historical context of development cooperation, the impact of geopolitical dynamics, and the influence of emerging global powers. The course also addresses contemporary issues such as climate change, economic inequalities, and the role of technology in development.

By engaging with case studies, theoretical frameworks, and practical examples, students will develop the analytical skills necessary to critically assess development strategies and their outcomes.

- Analyze case studies to evaluate the effectiveness and sustainability of multi-stakeholder partnerships.

# 4. Assess the role of the different actors of international development cooperation

- Understand the function and evolution of Official Development Assistance (ODA), bilateral aid, NGOs and philanthropic organizations within the international development system.
- Analyze the impact of multilateral organizations, such as the United Nations and the World Bank, on global development.

## 5. Explore Innovative Development Financing

- Investigate innovative financial instruments and mechanisms used to mobilize resources for development.
- Evaluate the role of emerging financial institutions and new development actors, such as the Asian Infrastructure Investment Bank and the New Development Bank.

## 6. Critically Examine Development Policies and Practices

- Critically evaluate various development policies and practices, including top-down and grassroots approaches.
- Understand the critiques and limitations of different development models, such as modernization theory and dependency theory.
